MEMBERSHIP PROCEDURE:

- The membership of the association shall be open to organizations of good professional reputation and standing who have been connected with Ice-cream industry for at least one year.
- All applications for membership must be made on the prescribed form.
- The applications for membership shall be considered by the Managing Committee in a duly convened meeting and approved by a majority of two third of the members present.

MEMBERSHIP CATEGORIES :

The membership of the association shall be composed of -

- (1) Ordinary Members (Ice cream/ Frozen Dessert Manufacturers)
- (2) Associate Members (Distributors, Dealers, Stockists, C & F Agents etc.),
- (3) Honorary Associates,
- (4) Foreign Associates, and
- (5) Affiliated Associates.

Ordinary Members (Ice cream/Frozen Dessert Manufacturers) shall be the owners of such Manufacturing Units in the country as may be approved by the Managing Committee and admitted to the membership of the Association and registered as such in the Register of the Association.

Associate Members (Dealers, Distributors, etc.) shall be the Proprietors of such Establishments in the carrying on business as dealers, distributors, stockist, C& F Agents , caterers of ice cream and frozen dessert products as may be approved by the Managing Committee and admitted as Associates of the Association and registered as such in the Register of the Association. The Managing Committee shall be the sole judge whether the establishment is falling within this category or not. Associates will have no right to vote.

Honorary Associates shall be only such individuals who had been concerned with, but are no longer concerned with, establishment represented in the Associationship of the Association as may be elected or invited by the Managing Committee to the Hon. Associationship of the Association and admitted to the Associateship of the Association and registered as such in the Register of the Association. In the event of any Honorary Associates becoming engaged in administrative capacity in an establishment, his Honorary Associateship shall at once cease. Honorary Associate will have no right to vote.

Foreign Associates shall be only the Proprietors of such establishments outside India, including Groups of entities falling within the approved categories as stated hereinabove who are approved by the Managing Committee and admitted to the Foreign Associationship of the Association and registered as such in the Register of the Association. The Foreign Associates will have no right to vote.

Affiliated Associates shall be the owners or proprietors of such establishment or individuals supplying all sorts of materials required for business by the members of the Association such as raw materials suppliers, machineries and its parts suppliers, food products suppliers, caterers, transporteres etc. as may be approved by the Managing Committee and admitted to Associateship of the Association and registered as such in the membership of the Register of the Association .The Affiliated Associate, however, will have no right of vote.

The Cheque / Demand Draft for payment of fees/subscription shall be drawn in favour of "Indian Ice-cream Manufacturers' Association".

CESSASSION OF MEMBERSHIP / ASSOCIATESHIP :

The rights and privileges of a Member shall not be transferable and shall cease:

- a) On the death of a Sole Proprietor of an establishment or concern which is member or in the case of Joint Proprietors on the death of the last survivor of the Joint Proprietors or in the case of a Corporate Body on such Corporate Body ceasing to have legal existence and on dissolution of a Partnership Firm;
- b) On such member ceasing to fulfill the criterion of membership required by Articles 6(a), hereof as the case may be;
- c) On such member giving notice in writing to the Association resigning his membership of the Association;
- d) On the expiry of one month after notice in writing requiring such member to withdraw from the Association shall have been given by the Managing Committee pursuant to the resolution passed by 2/3rd majority of the members present at a meeting of the Managing Committee specially convened for the purpose of considering the question of withdrawal, at which such member shall have been given a proper opportunity for attending and being heard;
- e) If his subscription shall be in arrears and not paid for 6 months after the same shall become due and payable whether demanded or not;
- f) If the member becomes insane or is declared an insolvent or is convicted of a criminal offense.

Any member whose rights as member shall at any time cease under the provisions of this or any other Articles shall ipso facto and immediately cease to be a member of the Association and shall not be entitled to claim a return of any money paid by him to the Association by way of subscription, fee or donation, but his ceasing to be a Member shall not relieve him of any liability already accrued under Clause 17 of the Memorandum of Association.

The aforesaid provisions for Cessassion of Membership shall apply to cessassion of Associateship also.
